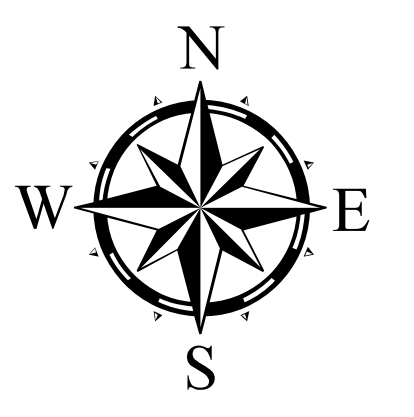

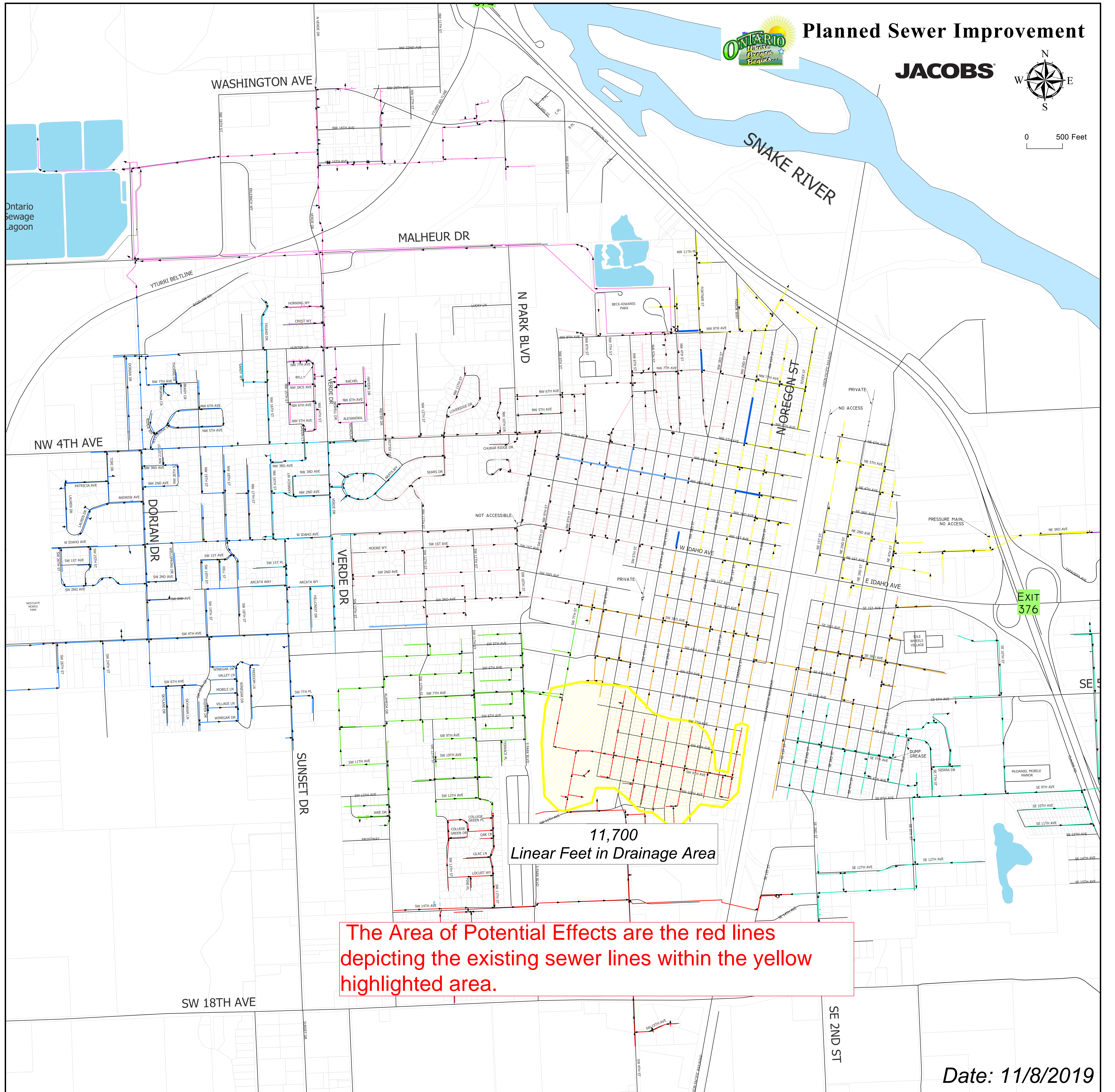

This technology is similar to lining the pipe with a sock that cures in place once installed. The insertion can be done within a manhole and no ground disturbance is required. The assemblage of materials is quite simple, as this is a flexible material prior to setting up in the pipe. As with bursting, this material would sit in the street adjacent to the entry manhole and machinery.
